### TERMS AND CONDITIONS

By entering the ‘Fill Out your details and sign up to our newsletter to win 4 nights accommodation at the InterContinental Fiji Golf Resort and Spa (LTPS), you are agreeing to the following terms and conditions:

#### 1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms of entry.

#### 2. WHO CAN ENTER?

2.1 Entry is open to all Australian residents aged 18 and over (hereafter ‘eligible entrant’).

2.2 Staff of Where Australia or their extended families and friends, are ineligible to enter.

#### 3. HOW TO ENTER

3.1 The competition commences on Friday 21st December at 9.00am and concludes on Wednesday 3rd April at 11.00am.

3.2 In order to enter, eligible entrants must enter their details on the vacationstravel.com website entry form. Eligible entrants must provide name, email address, street address and daytime telephone number.

3.3 Eligible entrants (including winners) in the competition may enter each prize draw only once.

3.4 Entries must be received by Wednesday 3<sup>rd</sup> April at 11.00am.

#### 4. PRIZES

4.1 There will be one (1) prize draw and one (1) winner. The winner will receive one prize package, as set out below.

- Airport shuttle transfers for two
- Full buffet breakfast daily – in either Sanasana Restaurant or the adults only Navo Restaurant (room service is not included)
- One buffer dinner for two adults at Sanasana Restaurant

- One snorkel safari experience for two

Blackout dates apply for the stay. These include the Australian school holidays, Easter, Christmas and the New Year period:

- 01/07/19 – 31/07/19
- 21/09/19 – 10/10/19
- 24/12/19 – 10/01/20

The prize is valid to be used and must be completed by 2<sup>nd</sup> April 2020.

- 4.3 If for any reason a winner does not take the prize and complete the relevant holiday before that date or once the prize has been booked, take the prize or an element of the prize by the date stipulated, then the prize or that element of the prize will be forfeited without further compensation.
- 4.4 The accommodation prize at InterContinental Fiji Golf Resort and Spa is subject to availability at the time of booking and blackout dates apply. Accommodation is in a Lagoon View Suite and must be taken on consecutive nights.
- 4.5 This offer is based on space availability and not valid during holidays or special events. Reservations are required and can only be made up to 30 days in advance.
- 4.6 Certificate must be presented upon check-in
